

Maintenance Planner / Engineer

The Swedish national air ambulance organisation, Kommunalförbundet Svenskt Ambulansflyg (KSA), is looking for an experienced CAMO maintenance planner / engineer.

About KSA

Kommunalförbundet Svenskt Ambulansflyg (KSA) is a national organisation formed, mutually owned and financed by all twenty-one (21) regions in Sweden. The purpose of KSA is to increase patient services and safety by making air ambulance more effective through coordination and coordinated use of common resources. KSA is currently establishing an AOC for the purpose of operating a fleet of six PC-24 EMS equipped aircraft for the Swedish regions. The aircraft will be based at the AEMS bases being established at Umeå (ESNU), Stockholm/Arlanda (ESSA) and Gothenburg/Landvetter (ESGG) airport together with flight crew, medical- and maintenance staff.

The planned start of operations is 2021.

Job description

Do you want to be part of our Continuing Airworthiness Management Organisation? You will work with planning- and engineering activities for our PC-24 aeroplanes, where monitoring and processing of the Maintenance Program, Service Bulletins, Airworthiness Directives and Work Orders are the main responsibilities.

Planning and monitoring of scheduled maintenance checks are done in close cooperation with the Part-145 Maintenance organisation (technicians) to ensure that the paperwork (Work Orders, Log cards, Technical Logs etc.) are correctly issued, signed off by authorized staff, and archived in the technical record systems.

Engineering activities includes monitoring and amendment of the Maintenance program to ensure it is always up to the latest standard. This includes Service Bulletins and Airworthiness Directives. You will regularly need to cooperate with and exchange information with manufacturer of the PC-24 aeroplane, the engines and miscellaneous systems and components.

Qualifications

You have a relevant engineering degree or hold an aircraft maintenance licence. Previous experience from continuing airworthiness management of a fleet of aircraft, preferably similar to KSA:s is required. Experience from maintenance environment is highly valued.

KSA is a small organisation and you must work structurally and independently for periods of time, especially during the start-up phase. Good communicative skill is essential. Fluent in English- and a Scandinavian language is required, in writing and speaking.

Comprehensive knowledge in Continuing Airworthiness Regulation (EU) No 1321/2014 Annex I (Part-M) and Annex II (Part-145) is required.
